Practice Areas

Qing Ren concentrates his practice on international trade, dispute resolution and anti-trust law.

Qing Ren has extensive experience in the field of trade law, including export control, economic sanctions, and supply chain due diligence. He has assisted leading domestic and foreign enterprises in various industries of aerospace, telecommunication equipment, semiconductors, machine tools, automotive, consumer electronics, household appliances, engineering, petroleum, chemicals, new energy, pharmaceuticals, internet, artificial intelligence, banking, insurance, and shipping, for trade compliance matters such as establishment or assessment of compliance program, compliance audit, transactions due diligence, and removal from restrictive lists. He has also advised the Chinese government for FTA negotiations and represented CCOIC in response to the USTR's 301 investigation against China. Qing Ren has been consulted by legislative and administrative authorities during the legislative process of the Export Control Law and related regulations.
